William Laddick of Scouport in the County of Devon a Gentleman in Gods Majesty's Year here do make this my last will and Testament as follows first I resign my soul to God that gave it me and my body to the Earth to be buried in a decent manner at the discretion of my Executors hereinafter named and as to what worldly Estate and Effects that I may die possessed of subject to the payment of my just debts funeral charges and the expense of proving this my Will I give as devise and bequeath the same and every part thereof as follows I give devise and bequeath unto my dearly beloved wife Elizabeth Laddick that my newly erected Dwellinghouse with the appurtenances or situate on the south side of Cannon Street in Scouport aforesaid for and during all my right title estate and interest therein for her own sole separate and absolute use and benefit and also all those and my two leasehold messuages tenements dwellinghouses outhouses shops and appurtenances thereto belonging or appertaining and usual in that and enjoyed therewith with a perpetual right of renewal tallies or commonly known by the name of Frogmore situate in a the parish of Charlton in the said County of Devon for her absolute use and benefit subject to the payment of the conventional rents services and fines for renewal and to the covenants conditions reservations and agreements in the leases or Grants thereof contained and incumbent on the Tenant or Lessee's part to be paid done observed and performed and also all my Chieff Monies that may be due and payable on my decease and also all my household Goods and furniture money and securities for money real and Personal Estate and Effects that I may die possessed of or entitled unto I hereby give devise and bequeath the same and every part thereof unto my said dear wife for her absolute use and benefit and after her decease to be equally divided as a between the legal representatives of my said wife and mine in equal moieties share & share alike and I hereby make certain constitute and appoint my said wife Elizabeth Laddick Executrix of this my last will and Testament hereby revoking and making void all former or other will or wills by me at any time heretofore made and I do hereby ratify allow and confirm this above and no other to be and contain my true last will and Testament the testimony whereof I the said William Laddick the Testator have hereunto set my hand and seal this fifteenth day of September our thousand eight hundred and twenty five. Wm Laddick He signed sealed published and declared by the said William Laddick the Testator as and for his last will & Testament in the presence of us as Wits at his request in his presence and in the presence of each or other have subscribed our names as witnesses hereto. Proved at London 4th Nov 1846 before the Judge by the oath of Elizabeth Laddick widow the Executrix the sole Executrix to whom a commission was granted having been first sworn by Commission only to do.

I hereby by my last will and Testament bequeath to my sister Margaret & John the interest of six hundred pounds and a quarter stock during her lifetime & I do declare that such interest is to be paid to herself on her own receipt for alimentary purposes and that the same shall not be subject to the jurisdiction

nor to the debts or deeds of her present or any future husband nor be
 assignable after her decease I bequeath the aforesaid principal sum to
 be equally divided betwixt my brother James & sister Elizabeth I do
 bequeath to my sister Elizabeth fifteen hundred pounds in the above
 stock I bequeath one thousand pounds to the children of my late brother
 John in equal shares in the above stock I bequeath one hundred and
 pounds to my eldest wife as a small mark of that affection I have
 long born to her in the above stock I bequeath my gold watch chain &
 seals & fifty pounds in the above stock to my nephew Wm. Halliday
 Lidderdale of Lott bank as a small recompence for his trouble as one
 of my Executors the above stock is part of what is placed in the Bank
 of England in the name of Halliday Lidderdale Falcon Square after
 the decease of my wife I bequeath to my brother James five thousand
 pounds three per cent Consols placed in the names of Wm. Stairland
 & Alex. Gordon trustees on my marriage or otherwise After such debts
 to the children of my late brother John fourteen hundred & thirty in
 right pounds seven shillings & sixpence three & a quarter reduced to
 stock standing in the names of Wm. Stairland & Alex. Gordon I leave
 my brother James my Residuary Legatee & my brother James or
 his son Wm. Halliday my Executors signed & sealed before my

 of the said Testator and this deponent referring to the seal appearing
 on the left hand corner of the said Will made oath that the said
 seal was so affixed by the said deceased at the time of executing his said
 will and was intended as his seal to the said will and that nothing
 was affixed thereto William Thornton / Same day the said William
 Thornton was duly sworn to the truth thereof Before me John Lamb
