of me William Robertson Lidderdale of Eastwood in the North  
 Riding of the County of York Esq<sup>r</sup> I will and direct that all my  
 just debts funeral expences and the Charges of proving this my will  
 may be paid as soon as conveniently may be after my decease by my  
 Executors and Executor hereinafter named and I do direct that my body  
 shall be buried in the most private and anatomical manner in the  
 Church Yard of that parish where it may please God to call me and  
 I give to all my Executors living with me at the time of my decease the Sum  
 of five pounds each in lieu of mourning I give and bequeath unto my  
 dear wife Julia Lidderdale and her Brother Mr William Rae Manufacturer  
 in Wiltou near Glasgow all the unexpired right term or Interest which  
 I now have or hereafter may have of and in the farm of Dain Sarrids  
 and grounds now occupied by me situated at Eastwood aforesaid together  
 with the Stock and Crop Implements of husbandry of and belonging to  
 said farm and also my household furniture plate Linen China Pictures  
 and Implements of husbandry household in my said dwelling house at  
 Eastwood aforesaid and all other my Estate and Effects whatsoever or  
 whatsoever or of what nature or kind soever either in money rents in the  
 funds bonds bills notes debts or otherwise and whether in possession  
 reversion remainder or expectancy to hold the same unto the said Julia  
 Lidderdale and William Rae their Executors admors or assigns upon this  
 special trust and confidence nevertheless that is to say upon trust as  
 soon as conveniently may be after my decease to sell and dispose of  
 the same and to call in and receive all such debts Sum or Sums of money  
 as shall be due or owing to me at the time of my death and place the  
 moneys arising by such Sale and disposal and the moneys so to be  
 called in and received upon Government or other good and sufficient  
 Securities in their own names and in such manner as they shall  
 think proper and also in trust that they do and shall receive the  
 Interest and Dividends thereof from time to time as the same shall  
 become payable and in the first place pay the same to my said dear  
 wife Julia Lidderdale on annuity or clear yearly Sum of fifty or a  
 pounds Sterling on two days or times in the year that is to say the  
 first day of May and the first day of November in every year the first  
 payment thereof to begin and be made on each of the said days as  
 shall first happen next after my decease and upon trust in the next  
 place to pay apply and dispose of the said Interest Dividends and  
 annual produce or a sufficient part thereof for and towards the  
 maintenance education support and bringing up of my Sons David &

lawfully begotten he she or they having married with the consent  
and consent of my said Trustees to be signified by any Instrument  
in writing under their hands respectively then In Trust to pay assign  
transfer and convey the part or share of such deceased Child or Children  
into such his her or their Issue share and share alike if more than  
one when and so often as they shall severally and respectively attain  
their several and respective ages of Twenty one years and to pay and  
apply the Interest Dividends and produce thereof in the meantime  
for and towards their respective maintenance and Education and so  
often as they shall think proper to alter and charge the Trusts on  
which the said residue of my Estate and Effects shall hereafter be  
placed out and from time to time as often as they shall think  
fit again to place the same out upon Government or such other  
good and sufficient Security and Securities as they shall think proper  
and I do hereby also authorize and empower my said Trustees to  
apply the respective part or share of any or either of their lawful  
Issue in case any or either of them die under age leaving Issue and  
having married with such consent as aforesaid of and in the said residue  
of my Estate and Effects for putting any or either of my said Children  
his her or their lawful Issue out to Business or any suitable employ  
or for setting him her or them up in Business or advancing him her  
or them respectively in any employ or otherwise for his her or their  
respective advancement in the world by marrying or otherwise howsoever  
any thing in this my will contained to the contrary thereof in any  
wise notwithstanding and it is my will and meaning that my said  
Trustees or either of them shall not be liable to answer or make good  
any loss or losses that shall or may happen to the aforesaid residue  
of my Estate and Effects in placing out the Trusts aforesaid according to  
the directions in this my will or in transacting any money affairs or  
otherwise relating to the execution of the Trusts mentioned in this my  
will unless the same shall appear to happen by or thro' their or  
either of their wilful neglect or default nor shall either of them  
my said Trustees be answerable or accountable for the acts debts or  
receipts or disbursements of the other of them but each of them

shall be answerable only for her and his own separate acts, debts  
 receipts and disbursements and I do hereby direct that my said  
 executor shall and may pay and reimburse themselves himself and  
 himself out of the above said residue of my Estate and Efforts all

 that they or either of them shall or may ever pay or be put unto  
 or sustain in or about the execution of this my will or the trust =
