This Will was proved at London the twenty
fifth day of February in the year of our Lord one thousand
seven hundred and sixty two before the Worshipfull
William Spry Doctor of Laws and Surrogate of the
Right Worshipfull Sir Edward Simpson Knight Doctor of
Laws Master Chieftee or Commissary of the prerogative
Court of Canterbury lawfully constituted by the Oath of
Sarah Langton Widow the Heir of the deceased and sole
Executrix named in the said Will to whom Administration
was granted of all and singular the Goods Chattels and
Credits of the said deceased having been first sworn duly
to administer. Et?

This is the last Will and Testament of me James

Nottingham Doctor in Physick made the seventh day of
February in the thirtieth year of the reign of our
sovereign Lord George the second by the Grace of God
of Great Britain France and Ireland King Defender of
faith and so forth and in the year of our Lord one
thousand seven hundred and fifty seven in manner
following that is to say. I will that in the first
place all my debts and funeral expences be paid
and discharged also I give and devise unto my son
John Lidderdale and to his heirs and assigns for
ever all that my Mesuage Tenement or dwelling
house wherein I now inhabit and dwell with the
outhouses Buildings yard Garden and appurtenances
thereto belonging and also all those my several closes
pieces or parcels of land lying near to and belonging
to my said Mesuage Tenement or dwelling house
now also in my own possession and also all other my
Mesuages houses lands Tenements and credits
whatsoever and wheresoever I hold unto my said
son John Lidderdale his heirs and assigns for ever
and lastly all my ready Money Writings Bonds
Bills Goods Chattels Effects and personal Estate
whatsoever and wheresoever I give devise and bequeath
unto my said son John Lidderdale and do make and
appoint him sole Executor of this my last Will and
Testament. In witness whereof I the said Testator
James Lidderdale have hereto set my hand and seal
the said seventh day of February 1757. James Lidderdale.

Testator James Lidderdale to be his last Will and

of the deceased and sole executor named in the
said Will to whom Administration was granted of
all and singular the Goods Chattels and Credits of the
said deceased he having been first sworn by
